\$1 Million from New York Helps Health Care Providers Connect to Rochester RHIO, Improving Electronic Records and Care

Skilled Nursing, Ambulatory Care Connect through Grant Assistance

Rochester, NY—November 6, 2019—More than \$1 million in New York State grants have helped 94 Rochester-area health care organizations securely connect to provide patient health records to Rochester RHIO. Through the Data Exchange Incentive Program (DEIP) started in 2017, RHIO has expanded its data sources to include groups such as skilled nursing facilities and diagnostic treatment centers.

"By having a more complete digital record of care for each patient, health care providers can make more informed decisions," said Jill Eisenstein, president and CEO of the Rochester RHIO. "As health care evolves, patients have records from many providers outside of traditional care facilities and hospitals that play a vital role in their overall health. With financial assistance from New York State, we're helping these organizations connect and contribute," said Eisenstein.

DEIP grants offset the set-up costs of technical connectivity for eligible providers—such as long-term care, diagnostic and treatment centers, outpatient and ambulatory care, and behavioral and mental health care organizations.

By contributing data to Rochester RHIO, organizations can add information such as medications, diagnoses, laboratory tests and results, care plans and procedures, creating a more complete medical record that spans multiple providers. It is used in conjunction with other RHIO services by hospitals, healthcare organizations, private practices and other ambulatory care sites to improve healthcare quality, coordination and efficiency.

Rochester RHIO is a critical link in the Statewide Health Information Network for New York (SHIN-NY). RHIO's mission is to provide better information to support high quality patient care for the region's health care community. By increasing data in the health information exchange (HIE), Rochester RHIO supplies a more comprehensive health care picture to a patient's treating physician and care team.

The New York State Department of Health (DOH), with support from Centers for Medicare & Medicaid Services (CMS) established the DEIP program to increase HIE adoption across the state for Medicaid providers. New York eHealth Collaborative (NYeC) is coordinating the program and the incentive payments on behalf of the State Department of Health.
