Performance Based Funding Metrics

- ORE & Physician data contribution Made goal
- 99% Uptime on Heartbeat Monitor Made goal
- NYeC User Survey Low participation, problematic survey, failed metric
 Question: Is the red on the chart related to the survey and low participation?
 Answer: the last line is usage and customer satisfaction. The median went down by 10 point
 and even though we are above the median we didn't get money for this metric as we didn't go
 above our total metric last year. So we lost about \$300K. Jill is speaking with Val to see if they
 can encourage NYeC to reconsider the way they are evaluating this metric. Was not just
 Rochester RHIO, appeared to be across other QEs as well.

 - o All labs now required to send results directly to RHIOs will improve quality
- Covid-19 vaccination Data plan to replicate above
 - Coordinate with Finger Lakes Vaccination Hub
- Patient Consent for telehealth
 - Under emergency allowing verbal consent
 - o After emergency new policy to operationalize informed telehealth consent
